To my DeKalb Community:

As most of you know, my company, APD Solutions, develops and advises on real estate redevelopment projects throughout metro Atlanta and the United States. Among those is the Panola Slope project, soon to be the Panola Resort on Covington Highway.

I see a means of changing the economic outlook of South/Central DeKalb with what we have envisioned for Panola Slope. The project is planned to be a resort for visitors and entertainment district for locals. We are bringing the finest amenities, unique experiences and safety to that corridor.

This new project will bring a total of \$28 million of new investment to the area. We are providing 3 new upscale restaurants, a one-of-a-kind Barcade, 4 retail boutiques, lodging of 72 sleeping rooms, swimming pool, outdoor performance pavilion and finally a top notch full service 10,000 SF conference center.

But attempts to lift up our community are never without controversy. Some media outlets are trying to suggest that because one of my investors owns casinos out of state, that this is a "backdoor" attempt to bring casino gambling to Georgia.

I am focused on bringing economic development to South DeKalb, not casino gambling. Households within a 5-mile radius of my site spend \$2 billion annually on restaurants and retail – and \$800 million of that is spent outside of DeKalb county. Private businesses and property owners must do our part to contribute to the economic vitality of our community. The citizens also can't complain about what we don't have and continue to spend nearly a billion dollars a year in other communities. Nor can I be a credible advocate for economic development if I am unwilling to take the risk on DeKalb that I ask of others.


